The Calcutta Scottish

The Calcutta Scottish was a regiment of volunteers of Scottish descent raised in 1914 as an infantry regiment of the British Indian Army. The regiment formed part of the army reserves known as the Auxiliary Force, India (AFI).

The Values and Standards of the British Army

As a soldier of The Royal Regiment of Scotland you will be expected to work to the values and standards of the British Army:

Selfless Commitment - Personal commitment is the foundation of military service. You must be prepared to serve whenever and wherever you are required, and to do your best at all times. This means you put the needs of the mission, and of your team, ahead of your own interests.

Courage - Courage creates the strength on which fighting spirit depends. You must have the physical courage to carry on with your task regardless of danger and discomfort, and the moral courage always to do what you know is right.

Discipline - The Army must be a disciplined force if it is to be effective. You must therefore obey all lawful orders that you are given. The best form of discipline which the Army expects from you is self discipline. Only that will earn you the respect and trust of your comrades, and equip you to cope with the difficult, individual decisions you will have to make during your service. This ap-

Their dress uniform included Hunting Stewart tartan kilts, and scarlet jackets.

An attempt was made to raise 2 kilted companies of "Calcutta Scottish" within the Calcutta Rifles, but without success. This may account for the date of the raising of the Regiment as being 1 August 1911 in Major Donovan Jackson's work "India's Army". The other date being 1 August 1914, when the Calcutta Scottish Volunteers were formed as part of the Indian Volunteer Force. King's and Regimental Colors (flags) were awarded after that date.

During the First World War the Regiment probably deployed only as individual reinforcements. Some officers are known to have gone to East Africa, but there is no record of deployment of the unit as a whole. There is a reference to Calcutta Volunteer Machine Guns armed with Maxim guns which may have included officers and men from the Calcutta Scottish having been on active service during the war. On 1 April 1917, the regiment was redesignated as the 44th Calcutta Scottish. In 1919, the 44th was called out for over 2 months to deal with "communal riots".

Postwar

On 1 October 1920, the regiment was redesignated The Calcutta Scottish (Army Auxiliary Force, India) and in 1921 included a Light Motor Patrol armed with Maxim guns (later Vickers, then

Lewis, then Brens) but mounted in private cars.


In 1921 the Prince of Wales visited the Far East in HMS Renown and on a visit to the city on 24 December inspected the Calcutta Scottish (photo

BENEVOLENT HEARTS KEEP THEM YOUNG

Editor The Chronicle-Sir: At a recent meeting of the oldest Scottish society in San Francisco some rather unusual events were recorded. First the secretary, George St. J. Bremner, celebrated his fiftieth year of membership. Secondly four members whose combined ages totaled over 320 years sang solos. I have heard many songs sung by much younger men who did not make the grade as well as these grand old men. Our beloved John McLaren surprised many by the tuneful rendering of a real old-time song by his wit when he made the presentation to his junior in years. Perhaps the climate has something to do with the long life of these men. I find on investigation that this Scottish society, which was established here in 1863, has quite an imposing list of members who can claim 80 years and better. Is it possible that we have any other societies in San Francisco which can make such a showing? Perhaps the nature of the society, benevolent, is the J. G. SCOTT. answer.

reason unknown, but probably due to riots again. The unit was inspected once more by the Prince of Wales in 1928.

In 1930 the unit was called out as Aid to the Civil Power for over 2 months in small detachments, at least 18 times.

Second World War

Individual members went off to serve on active duty. The remaining members were kept in Calcutta to continue working jobs deemed necessary for the war effort. British Military Intelligence had a hunch that German ships interned in the neutral Portuguese possession of Goa, a port on the west side of India, were sending out messages on Allied shipping traffic. An unofficial "commando unit" was requited for **Operation CREEK**, a special operation against the Axis ships in1943. The lead unit was the Calcutta Light Horse (15 members), but four members of the Calcutta Scottish also took part in the raid. The party sailed a barge into Goa harbor and caused the sinking of three German merchantmen: Ehrenfels, Drachenfels and the Braunfels, and one Italian ship – Anfora. The story of this "commando raid" was suppressed for reasons of security well after the war.

Operation CREEK was later described in the book "The Boarding Party" by James Leasor.. This so called "factional" account, in which the Calcutta Light Horse, reinforced by some members of the Calcutta Scottish raided the neutral port of Marmagoa on 9 March 1943. In the port, the "Ehrenfels" had been providing information to 3 German U-boats, on the movement of ships in the Indian Ocean. As result, some 250,000 tons of British shipping had been sunk over a period of 45 days. After a journey from Calcutta, via Bombay, in the hopper barge "Phoebe" the Ehrenfels was boarded and destroyed along with 2 other German ships, and one Italian vessel. The film 'The Sea Wolves', released in June 1981, was based on the book and stared Gregory Peck, Roger Moore, Patrick MacNee, David Niven and Trevor Howard. It was actually filmed in Goa. It is a fun film to see after a curry meal! In 1946 the regiment was reorganized to consist of an HQ, 2 companies and 4 Motor platoons, and disbanded in August 1947 following India's independence.

Integrity - Integrity involves honesty, sincerity, reliability and unselfishness. It is an essential requirement of both leadership and comradeship. Unless you maintain your integrity, others will not trust you and teamwork will suffer. Integrity sometimes requires you to show moral courage, because your decisions may not always be popular. But it will always earn you respect.

Loyalty - The Nation and the Army rely on your commitment and support. You must therefore be loyal to your commanders, your commades and your duty. If you are not, you will be letting others down.

Respect for Others - As a soldier you have the exceptional responsibility of bearing arms, and when necessary of using controlled lethal force. In addition, you will sometimes have to live and work under extremely difficult conditions. In such circumstances, it is particularly important that you show the greatest respect, tolerance and compassion for others because comradeship and leadership depend on it.

Uniform

The jacket was scarlet with white facings, but by 1946 the jacket changed to yellow facings. The Regiment wore Hunting Stewart tartan. Kilts were rarely worn during WW2.

The **Glengarry** (on left): 1914-20: Diced Green and white. By 1946: Royal blue with same color ribbons (Argyle). Sun helmets were worn most of the time. Also red and black check/diced glens were worn.



The hose tops were green and white, but by 1946 they became tartan with red flashes. Also red and black check/diced. The cap badge (seen in Glengarry photo) was the

Cross of St Andrew with the coat of arms of Calcutta superimposed, in the upper angle of the cross a crown. The Regimental Motto: <u>Per Adua Stabilis Esto</u> (Be firm through difficulties) was included. The sporrans were white with six black tassels.

The King's and Regimental Colors and the Regimental Silver were passed along to the London Scottish on disbandenment. In 1953 they were sent to the United Services Museum in Edinburgh Castle. They are now on display in the National War Museum of Scotland.


