5, Elizabeth Montgomery, daughter of John Montgomery and Margaret Miller, married the Rev. John G. Landrum. Dr. J. B. Landrum is their son and is an author of note, and wrote this sketch.

6, John Crawford Montgomery, died small.

7, Michael Miller Montgomery, married Martha Cora, of Neuse District, S. C. Their son, John Oscar Montgomery, was in the 18th regiment S. C. Vol. and killed at second Manassas.

8, Chevis C. Montgomery, married Mary McCarrell of Greenville District, S. C.

9, Hannah Amanda Montgomery, married Col. S. N. Evans—second wife.

10, Catherine Montgomery, married Edward Ballenger.

11, Heron Earl Montgomery, married Sarah Ballenger.

12, Robert Scott Montgomery, Sr., married Catherine Gaude-lock, of Neuse District, S. C.

13, Margaret Montgomery, married William Moore of Morgantown, N. C.

3, James Montgomery, son of John Montgomery from Pennsylvania, married a Miss Walker and had two sons—John W. and Robert Montgomery.

4, Robert Montgomery, son of Pennsylvania John, never married.

5, Hugh Montgomery, son of Pennsylvania John, had eight children: John, James, Thomas, Walker, David, Elias, Mary and Elizabeth. Of these, Mary married a Gross and Elizabeth married Shadrach Barton.

6 and 7, Mary and Elizabeth Montgomery, daughters of Pennsylvania John—no information.

"BOYNE WATER" MONTGOMERY FAMILY, OF DELAWARE, PENNSYLVANIA AND OTHER STATES.

1, Major William Montgomery, great-grandson of Lord Nicholas Montgomery, who married the daughter and only heir of Lord Lyle, about 1500. This great-grandson, Major William Montgomery, was killed in the battle of Boyne Water, which was fought near the town of Drogheda, Ireland, July 1, 1690. Captain William Montgomery, son of Maj. William Montgomery, was wounded in this same battle and had two brothers killed in the same. He was afterward promoted to major in his father's regiment, and in all the records of this family he is known as the "Boyne Water Major." He married the daughter of William Dunbar.

"Boyne Water Major" William Montgomery came to America about 1720 and settled in Delaware. He had several brothers, but all died without issue. He had sons as follows: John, the eldest, who went to sea and was never heard of afterward; however, there are several things that tend to show that he went to Virginia and was the father of the John Montgomery who was a lieutenant colonel of George Roger Clark's regiment, which on July 4, 1778, captured Kaskoikie, in Illinois, and later captured Vincennes, Ind., from the English. See index—Col. John Montgomery.

Robert, the second son of "Boyne Water Major" Montgomery, had children—Magaret, Sarah, William, Hugh, Matthew, Jane and Robert. Of this family little is known—all living at this time (1844) in Delaware—from old papers in this family.

Alexander, the third son of "Boyne Water Major" Montgomery, came to America in 1740; died 1747. He married a lady named Mary ———, in Ireland, and had four sons and two daughters: 1. John; 2, Moses; 3, William, born in 1736; 4, Daniel, born probably 1738; 5, Margaret, born probably 1740.

John Montgomery, son of Alexander Montgomery, born probably 1732, married and moved to North Carolina, on Deep River, above Fayetteville about 30 miles. He had six or eight daughters, but no son. One of his grandsons took his name, and at this time (1836) is said to be a respectable member of the legislature.

Moses Montgomery, born about 1734, son of Alexander Montgomery, had at least one son, who settled in Williamson county, Tenn., about 1838.

William Montgomery, born Aug. 3, 1736, in Chester county, Pennsylvania, afterward of Danville, Pa., makes the following interesting statement concerning himself and family, which is found recorded in the old family Bible, later in the possession of Mrs. Hannah Lawhead:

"By the goodness of Divine Providence, Aug. 3, 1809.

"I have this day numbered seventy-three years (not noticing the change of style), and it is but right that I should have a record of something of God's goodness to me in so long a life. I was the third son of Alexander and Mary Montgomery, who both died, leaving me an orphan ten or eleven years old, but by the restraining grace and goodness of God I was led up through the slippery paths of youth up to manhood. I early married Margaret Nivins; she was all that could be expected in a woman; she was pious, sensible and affectionate. She lived with me about 13 years and had issue—Mary, who died at the age of 23 years; Alexander, who died in infancy; Margaret, who died in the same year with her sister; William, who is still alive and has a large family—is now about 47 years old, born 1762; John, who is about two years younger, and also has

a large family; Daniel, who is two years younger, born 1766, and has a family; Alexander, who died about one year old. About 22 months after her decease I married Isabella Evans, a most distinguished and delightful woman, by whom I had issue—Robert, born in April, 1773; Hannah, born 22nd of January, 1775; Alexander, born October 2, 1777; and Margaret, born January 8, 1784. The three former are still living, but she died soon after her marriage with Thomas Woodside; but their mother was called away from me in August, 1791. and in April, 1793, I again married a worthy and eminent woman. Her maiden name was Boyd and she was the widow of Col. Matthew Boyd, by whom she had issue—John, who died with the dysentery, aged about 23 years; also Rebecca, who is married to the Rev. John Patterson; lives happy and is raising a fine family. But I have had no issue by my present wife, nor has any uneasiness arisen in consequence of it, nor can it be said that any of my children have had a step-mother, being always treated with as much tenderness and respect as they could have expected from their own mother. Another instance of my happiness, and for which I ought to be very thankful, is the untarnished morality of my children, and the peace and harmony that has always subsisted among them. Through all this long life I have been abundantly provided for; have enjoyed honors enough unsought by any other means than honestly endeavoring to do my duty to my God and my country; great health and much comfort, retaining my natural powers with little diminution till about five or six years past, since when I feel sensibly the advance of old age; but I hope that the goodness and mercy which have followed me all through life will not forsake me when gray hairs appear, but continue to conduct me safely down to death; after which, through the merits of our Lord Jesus Christ alone, and the mercy of God our Savior, I hope to obtain eternal rest and happiness.

“Note.—This year the woolen factory at Danville was established under my care.”

(The above is a true copy of what appears to be an original draft made by James Montgomery, who is the son of Jeff. T. Montgomery of Sumner Co., Tenn., who was the son of Wm. Montgomery of the same place, who was the son of Wm. Montgomery of Danville, Pa.)

This William Montgomery was a gentleman of strong mind. He was censor of Pennsylvania in 1776, a peculiar office under the constitution of Pennsylvania at that date. (Charter and Constitution of United States, Part II., pages 1540-42-43.) He was prominent in settling the disputes concerning the boundary lines of northern Pennsylvania; was county judge, mayor, general of militia, and

owned many thousand acres of the best land in Pennsylvania. In 1776-7 he commanded a regiment of state militia for six months in service. His son William, born 1762, was 15 years old at that time, and served with him in the Revolutionary service. The elder William Montgomery served in the legislature of Pennsylvania, and in Congress. He died in 1816, aged 80 years.

The younger William Montgomery, named above, born 1762, married Jane McMillan about 1788, and soon after settled on Drake's Creek, Sumner county, Tenn., where he died in 1838. They had sons Daniel, John, Robert, William, Jefferson T.; and daughters Margaret, Jane, Hannah, Polly—who died in infancy—and Elizabeth.

John Montgomery, son of William, Jr., had sons William, Fielding T., John, Robert and Daniel.

John Montgomery, born in Pennsylvania in 1764, and died in that state in 1834 or '35, son of William Montgomery, Sr., married Elizabeth Bell in 1788, who died in 1836; children, William, James, Daniel, Jane, Margaret, John, Rebecca, Mary, Elizabeth, and four others who died in infancy.

About 1822 or 1823 William (son of John) married Jane Robison; they went to Arkansas as missionaries. His wife died shortly after the birth of her first child; the child died soon after. He married for his second wife Mary Weller, who died shortly after giving birth to her first child, Mary Weller. His third wife was Harriet Woolley; she had one child—James Lawhead. William Montgomery died of cholera in 1834; he and his three wives and oldest child are all buried on mission ground in Arkansas. Mary Weller in 1847 married Rev. T. P. M. Walker and is living in Hancock county, Ill. Their children are William M., Alexander F., James M., Maggie M., Thomas M. and Charles G. William M. died of consumption when about 22 years old. Alexander married, 1874, Nettie Mull, and is living in Rock Island, Ill. James Lawhead, son of William Montgomery, died in New York City, unmarried.

James, son of John Montgomery, married Margaret Reed, March, 1821. Their children were Jane Elizabeth, born Feb. 23, 1822; John, born March, 1823; Caroline, born Aug. 13, 1824; Louis R., born April 14, 1826. John died in infancy. James Montgomery died in Pennsylvania, Aug. 1826, aged 35 years. In 1836 his widow and three daughters moved to Monmouth, Ill. Jane E. died in Mercer county, Ill., Aug. 1843.

Caroline Montgomery, born Aug. 13, 1824, daughter of Capt. James Montgomery, married George Poage Rice, Feb. 4, 1841. He was born Oct. 27, 1812, in Greenup (now Boyd) county, Ky. He died July 7, 1890, in Omaha, Neb., and was buried in Monmouth, Ill. He studied for the Presbyterian ministry in Clarksville, Tenn.;

moved with mother and brothers from Christian county, Ky., to Monmouth, Ill., in 1835. With his brother he kept store in Monmouth a few years; farmed in Henderson county, Ill., till 1857, then moved to Oquawka and entered the mercantile firm of Phelps & Rice, which continued four years, when he retired. He was 40 years a ruling elder in the Presbyterian church. His children were: James Montgomery, born March 8, 1842; John Hopkins, born Feb. 14, 1844; William Cyrus, born April 30, 1846, died May 8, 1850; Jane Elizabeth, born July 30, 1848, died May 18, 1849; Mary Louise, born June 15, 1850; Carrie M., born April 15, 1853; Ann, born Oct. 1856, died in infancy; Charles Edward, born Nov. 3, 1858.

James Montgomery Rice, born March 8, 1842, at Monmouth, Ill., son of Caroline Montgomery-Rice, lived in Henderson county, Ill., on a farm until 1847; home in Oquawka; freshman Monmouth College, class 1860 to 1861. Aug. 20, 1861, he enlisted as a private in Co. E, 10th regiment Ill. Inf., for three years; was corporal and sergeant, and detailed clerk at brigade headquarters; was in many battles—Corinth, Pittsburg Landing, Missionary Ridge, Ringold, Buzzard Roost, Resaca, Peach Tree Creek, Ezra Church, Jonesboro. Capture of Atlanta, and others; a member of National Guard of Illinois from May 30, 1875; General Inspector R. P. of Illinois National Guard for many years—resigned Jan. 1896; member of state legislature 1871-1872, which revised statutes after adoption of the new constitution; member of General Assembly, Presbyterian church in the United States, 1838, 1899 and 1900. He was the author of the new method of electing standing committees—see Appleton's American and English Encyclopedia 1900. He was also author of declaration of war with Spain. He graduated at law school, Michigan University, LL. B., 1866; was admitted to Supreme Court of Illinois, April 14, 1866; in 1877 city attorney of Peoria, Ill.; member of State Bar Association; principal organizer of Peoria Law Library Association; admitted to practice in Supreme Court of United States, March 26, 1890. He married Eliza F., daughter of Col. Charles Ballance, a lawyer of Peoria, Ill., who was first colonel 77th Ill. Vol. Inf., and Julian Margaret, nee Schnebly. Eliza was born at Peoria, Ill., Jan. 26, 1844; graduated at Monticello Seminary, Godfrey, Ill., near St. Louis; died Feb. 17, 1895, and was buried at Peoria; a faithful member of Presbyterian church and several patriotic ladies' societies. Their children were: Lillian Ballance, born March 26, 1873; Julia Margaret, born Oct. 28, 1874; died March 4, 1875; Caroline Montgomery Rice, born March 18, 1876, student of Smith College, Northampton, Mass., taught in public schools of Peoria, Ill., and Denver, Col., member of second Presbyterian church; Mary Virginia, born Oct. 18, 1880, graduated A. B. of Michigan University, June 1902; Montgomery Gordon, born Aug.

24. 1882. student Sophomore Bradlet Polytechnic Institute, Peoria, Ill.; Willis Ballance, born Dec. 6, 1884, graduate of June, 1901, Peoria high school.

John Hopkins Rice, born Feb. 14, 1844, married Dec. 29, 1869, to Margaret J., daughter of Judge Preston Martin and Ann Elizabeth, nee Taylor; enlisted Aug. 10, 1862, in Co. C, 91st Ill. Vol. Inf.; promoted corporal sergeant, 1st sergeant, and 1st lieutenant; mustered out July 12, 1865. On Dec. 26, while guarding the bridge over Salt river, Ky., was captured by Gen. John Morgan, the raider, and paroled; remained in parole camp at St. Louis, Mo., until exchanged June 5, 1863; moved to Vicksburg, Port Hudson, New Orleans, Morganzia, La., Brownsville, Tex., Brazos de Santiago, Texas, Palo Alto, Mobile. He was a farmer, justice of the peace, school director, treasurer school board, member of Presbyterian church; moved to a farm near Wichita, Kansas, Feb. 14, 1900. His children are: Frank Montgomery, born Sept. 1, 1871; lives near Wichita, Kansas; is a farmer. Ann Louise, born Sept. 2, 1873; died Dec. 17, 1873. Sallie Plumer, born July 31, 1876; member of Presbyterian church; is teaching school near Wichita. William Cyrus, born March 9, 1880; member of Presbyterian church; is a farmer near Wichita. Mary, born Oct. 2, 1884, died Sept. 24, 1885. Eva M., born Aug. 3, 1886.

Mary Louise Marriott, nee Rice, born June 15, 1850, married John Thomas Merriott, May 29, 1879; taught school at Mineir, Ill., Brimfield, Ill.; was assistant principal of Elmwood high school; member of Presbyterian church; studied at Peoria county normal school, and at Valparaiso, Ind.

John T. Merriott is a merchant and broker at Wakefield, Neb.; was born March 6, 1855, in Brimfield, Ill.; son of William and Sarah (nee Percy) Merriott, who were born and married in Lincolnshire, England.

John T. Merriott and family moved to Wakefield, Neb., in 1881, and still live there. Their children are: Caroline Montgomery, born March 24, 1886; graduated at Wakefield high school, class of 1902, and lives with her father and mother. William Henry, born Sept. 16, 1888; student at Wakefield high school.

Carrie M. Rice, born April 15, 1853, Henderson county, Ill., married in Monmouth, Ill., Lyman Weeks Case who was born Dec. 1, 1853, at Swanton, Vermont—son of Samuel Montague Case, born June 6, 1821, Fairfax, Vt., and Ann Maria Babcock.

Lyman W. Case is a loan broker and loan agent. He moved from Peoria, Ill., in Sept. 1889, to Omaha, Neb., where he still resides. The children are: Bertha Case, born Aug. 19, 1873, graduate of Neb. State Normal, Peru, Neb.; united with Westminster Presbyterian church, Omaha, 1889; teacher in Omaha public schools

since 1899. Frederick Albert Case, born April 13, 1880; died June, 1881. Montgomery Babcock Case, born Feb. 11, 1882; student University of Nebraska.

Charles Edward Rice, born Nov. 3, 1858, married Emma Lyon; graduate of Monmouth College 1877; graduate Omaha, Neb., Theological Seminary, 1875; ordained a Presbyterian minister March, 1894; pastor of Carey and other small churches in Nebraska since 1895; was engaged in work for the American S. S. Union from 1887 to 1892; now resides at Hotchkiss, Colorado.

Lillian Rice Brigham, nee Rice, born March 26, 1873, married Sept. 4, 1896, Daniel Rufus Brigham, son of Daniel Morgan Brigham and Lillian Brigham, nee Card, of Milwaukee, Wis. Lillian graduated from Smith College, Northampton Mass., June, 1894; was professor of history and English literature in Normal School of Arizona, 1896-7. Her husband, Daniel Rufus Brigham, born April 10, 1865, died at Denver, Colorado, Feb. 19, 1902; was son of Daniel Morgan Brigham and Lydia Brigham, nee Card, of Milwaukee. Their children are: Daniel Morgan, born May 8, 1899. Caroline Rice, born March 1, 1901.

Nov. 22, 1872, Louisa R., daughter of James Montgomery, married William B. Jamison, a widower with three children—Alpheus, Alma and Janie, aged respectively 22, 20 and 10 years.

Alpheus married Carrie Moutieth, Oct. 5, 1875, and is living on a farm in Henderson county, Ill.

Alma married Joseph Carter, Sept. 1871. They have one child—Ernest O., aged 4 years. They are living on a farm in Henderson county, Ill. Janie is living with her parents in Biggsville, Ill.

Daniel, son of John Montgomery, married Christiana Giffin, 1826, who died of consumption when her first child, William G., was about nine months old. In 1835 he married Margaret Simington. Their children were Robert S., John, Daniel and James. William G. married Jennie Titterington. John married Miss ———. Daniel married Aurilla Parks. James is a merchant, unmarried, living in the city of Rock Island, Ill. The four married brothers are farming in Rock Island county, Ill. Their father, Daniel Montgomery, died of spinal disease in 1848. His widow is living with her maiden sister in Milan, Rock Island county, Ill.

Jane, daughter of John Montgomery, married Rev. William Requaro, missionary to the Indians, in 1834. She died childless shortly after reaching the mission ground.

Margaret, daughter of John Montgomery, married Thomas Candor, 1824. Their children were John M., Robert, Josiah, Elizabeth, Mary and Daniel Montgomery. John died just as he had finished his theological course at Princeton, N. J., aged about 23.

Robert married Rebecca Lynn; their children are John, Thomas, Ward, Loomis, Maggie, Sadie and Mary. Josiah married Nellie — —; their children are Carrie, May and Robert. Elizabeth died in infancy. Mary married Graham Lee; their children are Elisha, Maggie, Milo, Fannie, and an infant who died shortly after its mother in 1874. Maggie died a few months afterward. Mr. Lee is married again.

D. Montgomery Candor married Miss ———. The Candor brothers are all living near each other in Rock Island and Mercer counties, Ill. Mrs. Margaret Candor died in 1841, not quite two years after Mr. T. M. Candor married his second wife, Mary L. Broadman. He died in 1870 or 1871, in Aledo, Ill., and his widow died about a year after at the residence of her step-son, D. Montgomery Candor.

John, son of John Montgomery, was a Presbyterian minister. He married Sarah, daughter of Rev. Wm. Vail, missionary to the Indians. Their children were Joseph V., William F., Christiana S., Asenath, Elizabeth, Daniel and Sarah. Joseph V. married Anna ——— and is living in Kewanee, Ill. Christiana S. married Washington I. Moore, a retired sea captain, and is living in Lynn, Conn.; their oldest child is named Kathleen. William F. is in Cincinnati. Asenath is married and living in Iowa.

Mr. John Montgomery, his wife and twin children—Daniel and Sarah—all died in 1843. Elizabeth died about a year before.

Rebecca, daughter of John Montgomery, Sr., married Rev. Matthew Patterson, a widower with two children—John and Sarah; they are both married and living in Freeport, Ill. Rebecca died childless. Mr. M. Patterson is at present in Freeport, Ill. Mary married Hopkins Boone; their children were H. Montgomery, Jane Elizabeth, Hannah B., and nine others who died in infancy. Montgomery died in battle in New Mexico during the late war. Elizabeth married Benjamin Burroughs. She died in 1870 leaving four children—Anna, Eva, Mary and Libbie. Mr. Burroughs has since married again and is living in Quincy, Ill. Hannah married John Geddes; their children are Thomas Boone, Mary M., Alexander Walker, and Frank. They are living at Farlow's Grove, Mercer county Ill.

Elizabeth, daughter of John Montgomery, Sr., married William Sheriff and died childless.

Mary Montgomery, wife of Hopkins Boone, died in 1858.

About two years after, Mr. Boone married his second wife, Mrs. Hinds, a widow with two children—Fannie and Jennie. Mr. Boone is living in Aledo, Ill. Fannie and Jennie are married and living in Mercer county, Ill.

Each member of the family of John Montgomery, Sr., that had any descendants living was represented in the late war.

Rev. T. P. M. Walker, son-in-law of Wm. Montgomery, was chaplain, and his son William was also in the army. Jas. M. Rice, who furnished part of the data for the above history, and his brother, John H. Rice, grandsons of Captain James Montgomery, each served three years—the former as sergeant and the latter as first lieutenant. Robert S. Montgomery, son of Daniel, was captain of a cavalry company and was wounded at Lexington, Mo.—supposed to be mortally, but he recovered and served out his time. Wm. F., son of John Montgomery, had his horse killed under him at the battle of Wilson Creek, Mo., but he escaped unhurt. Montgomery Candor, son of Margaret Montgomery, was a captain in the army. Montgomery Boone, son of Mary Montgomery, was a member of a Colorado regiment and was killed in New Mexico. Elizabeth and Rebecca Montgomery had no children. General William Montgomery's son John, born 1764, was a colonel of the state militia of Pennsylvania. There is an interesting circumstance about this Gen. William Montgomery, the Revolutionary colonel. Later in life he was made a major-general of the militia. His son Daniel was a brigadier-general and commanded one of the brigades in his father's division. His other son, John, was a lieutenant colonel of one of the regiments in Daniel's brigade, and James Montgomery, a son of John, was a captain in his father's regiment; so that a paper forwarded from him to the governor would go first to his father, John, then to his uncle, Daniel, and then to his grandfather, William Montgomery.

Daniel, born 1766, son of William Montgomery, Sr., was a member of Congress for several years. He married Christiana Strawbridge of Scottish descent; their children were Hannah, Margaret, William, Mary, Strawbridge, and several others who died in infancy. Hannah married John Boyd, Margaret and William died unmarried, Mary married Dr. McGill, Strawbridge married Sarah Breadenburg, a daughter of a German reformed minister; they had one daughter who married a Presbyterian minister.

Robert, born April, 1773, son of William Montgomery, Sr., married for his first wife Miss Boyd; their children were Mary Nivan and one son. His second wife was Mrs. Louisa Edwards, by marriage niece of Rev. Jonathan Edwards; she had two children when she married Mr. Montgomery, and two afterward. Hannah, daughter of Gen. Wm. Montgomery, born Jan. 1775; married James Lawhead; they died childless.

Alexander, born Oct. 2, 1777, son of William Montgomery, Sr., married Jane Boyd; their children were Mary Eliza, Isabella, Hannah, Margaret, and a son who died in infancy. Isabella married Michael Grier, son of Isaac Grier, D. D., a brother of Judge Robert Grier. She died leaving five or six children. Shortly afterward Mary Eliza married her brother-in-law, Michael Grier. They are

living in Danville, Pa. Hannah married Andrew Russel; they have a large family and are living in Danville, Pa. Margaret is unmarried.

Alexander Montgomery died a number of years ago. His wife, Jane Montgomery, is still living (1876). I think she must be nearly 100 years old.

William Boyd, step-son of William Montgomery, Sr., died unmarried.

Rebecca, step-daughter of William Montgomery, Sr., married John B. Patterson, a Presbyterian minister; their children were Margaret, Matthew, William, John, Jane, Rebecca, Hannah, Robert and Elizabeth. William and John died unmarried. Matthew is a Presbyterian minister. He married for his second wife Rebecca Montgomery. The daughters are all unmarried, living at the old homestead, Montour county, Pa. Robert married Josepha McCoy and is living in Centralia, Ill., in the railroad business.

Captain Daniel Montgomery, born probably 1738, fourth son of Alexander Montgomery, was with Washington at the battles of Trenton and Princeton, in the Revolutionary War. He married Margaret Williard, a descendant of Rev. Samuel Williard. First Presbyterian minister of Boston. Captain Daniel Montgomery moved from Philadelphia to Northumberland county, Pa., and founded the town of Danville. He died 1823 or '24.

Hon. William Montgomery, born in Philadelphia, 1774, only child of Captain Daniel and Margaret Montgomery, was for many years judge in Northumberland county, Pa. He married Jane Hayes, niece of the Hon. Andrew Hayes, member of the Continental congress. Judge Montgomery died in 1847.

Rev. Samuel Montgomery, third child of Judge William and Jane Montgomery, was born April 15, 1814, in Danville, Pa.; married Mary E., daughter of Dr. Samuel McKeehan, of West Alexander, Pa. Samuel Montgomery preached in Pennsylvania and Ohio, and died in Oberlin, Ohio, March 19, 1887; children—Elizabeth M., who died in infancy. 2. Elizabeth B., single; lives in Cardillac, Mich. 3. Narcissa Y. Montgomery, married H. H. Couchman, of Ft. Calhoun, Neb.; children two: 1, Mary E. Couchman, married Rev. Charles A. Arnold, Ord, Neb. 2, Anna C. Margaret Montgomery, born probably 1740, one of the daughters of Alexander Montgomery, married a Mr. Strawbridge, near Danville, Pa., and died about 1839 at the age of 98 or 99 years.

MONTGOMERY—HOUSTON FAMILY OF PENNSYLVANIA,
VIRGINIA AND OTHER STATES.

William G. Montgomery, of Birmingham, Ala., has kindly sent me the book containing the Montgomery-Houston genealogy, with whom the Montgomeries are connected. This book was published about 23 years ago. He says:

"Our records are not entirely complete. Our family are also Scotch-Irish—descended, we think, from the Skelmorlie branch. Our ancestor, John Montgomery, Sr. (Generation 3), came to America about 1730 or before; came to Pennsylvania or Delaware; married Esther Houston, daughter of John Houston, probably 1751, and moved from Pennsylvania to Augusta county, Va., settling between Stanton and Lexington, Va., near New Providence church.

Esther Houston came with her father, John Houston, from Ireland about 1735. She was born about 1724. They settled in Pennsylvania and remained there until the three oldest children were married, when they emigrated to Virginia, as above stated. Children twelve: 1, John, Jr.; 2, Mollie; 3, Ann; 4, James; 5, Dorcas; 6, Jane; 7, Robert; 8, Esther; 9, Alex; 10, Isabella; 11 and 12, two daughters.

1, John Montgomery, Jr., born 1752 (No. 1, Gen. 4), was a Presbyterian minister, highly respected for his talents, piety and usefulness. He was a popular preacher, a good scholar, an esteemed relative and an admirable man. He began his education in one of those famous Scotch-Irish log colleges; this one being located on Timber Ridge, Augusta county, Va., and being conducted successfully by the Rev. John Brown and William Graham. Rev. John Montgomery completed his education at Princeton College, New Jersey, graduating 1775; and returning to Virginia was ordained by Hanover Presbytery at Tinkling Springs church, Augusta county, Va., April 26, 1780. He settled first in Fredric county, Va., and preached in Winchester, Opequon and Cedar Creek churches for a time, and then moved to Rocky Springs church, in the "Pasturs" of Rockbridge county, Va., in 1789, where he died in 1818 at the age of 66 years. This church is situated not far from where "Windy Grove" and Lebanon churches now (1879) stand. He married Agnes Hugart, 1772, daughter and only child of Col. Thomas Hugart and Rebecca Estill, near Rocky Springs, Va. Mr. Waddell, in his history of Augusta county, Va., says Colonel Hugart was colonel of a Revolutionary regiment under LaFayette, and was also high sheriff of Augusta county, Va., and a wealthy planter, owning large grants of land and the greater part of Deerfield valley in that county. Rev. John Montgomery had seven children: 1, Esther; 2, John; 3, Thomas; 4, William; 5, Isabella; 6, Hugart; 7, Estelline.

1, Esther Montgomery, born 1785 (No. 1, Gen. 5), died Feb. 1850. She lived single for many years and then married Rev. James C. Wilson, pastor of the Presbyterian church of Waynesborough, Augusta county, Va., an excellent, able minister who died not long afterward, very suddenly, while receiving his mail at the post-office. She was a truly pious, intelligent and estimable lady, extensively known and much beloved. A large circle of relatives and acquaintances called her familiarly "Cousin Hettie." Her social qualities were of a high order. She died at 67 years of age without children.

2, John Montgomery (No. 2, Gen. 5), born 1788, died 1829; married Elizabeth Nelson, of Augusta county, Va., Nov. 11, 1813. Elizabeth Nelson's father came from Ireland when he was 17 years of age; had been well educated and taught school for some time. A merchant friend of his, Robert Manis of Philadelphia, the celebrated financier, told him to purchase largely of molasses on which to speculate, and he would advance the money. Young Nelson accepted the kind and liberal offer, obtaining on his sales a very handsome profit. He served as clerk for his friend for some time, but afterward established an independent business and, prospering greatly in trade, finally became sole proprietor of three ships, importing largely from abroad. But, war ensuing, his ships were captured by the French and he was reduced almost to penury; but by industry and tact for business he recovered so far from his prostration that he lived in comfort the rest of his days.

John Montgomery (No. 2, Gen. 5) was an elder in the Presbyterian church and his home is near where Goshen depot is situated, in Rockbridge county, Va. His wife, Betsy Nelson, had a brother James with whom the distinguished Courad Speed, D. D., made his home for many years, in Augusta county, Va., and he often entertained his friends by telling them of the sayings and doings of that very learned but somewhat eccentric divine.

Elizabeth (Betsy) Montgomery was a rather small woman and somewhat delicate, remarkably lively and cheerful in disposition, much loved by her children and friends. She told the writer on one occasion, when we were trying to trace out an exact kinship but could not succeed as well as we desired, "Well, I always claim kin pretty far off, if it is good."

We are only able to present brief accounts of the children. We regret that it is so, since they have always been regarded as occupying high ground among the best of our citizens in Virginia and elsewhere. They lived at Goshen, Rockbridge county, Va. Their graves near Goshen are close to the railroad, west of town, and have a large flat stone in a good state of preservation (1902). Children seven:

Their eldest son, Alexander N. Montgomery (No. 1. Gen. 6), born 1814, never married; was a member of the Episcopal church and died in 1859, aged about 45 years.

John J. Montgomery (No. 2, Gen. 6), born Dec. 19, 1816, died June 13, 1892; was an elder in 1881 in McElhany church, Greenbrier county, Va.; was a good Christian man, faithful as an officer of the church, took much interest in Sabbath-schools; unassuming and retiring, with much good, practical common sense and quiet humor. He lived for many years in the town of Lewisburg, W. Va. His wife was Margaret, the daughter of T. Craigh, who was a well-known and wealthy merchant and land-owner of Greenbrier county, Va. John J. Montgomery and Margaret Craigh had eight children: Lilly E., Bettie A., John T., Louis W., Nannie C., James A., Maggie C. and Samuel A.

Lilly E. Montgomery (No. 1 Gen. 7), born Aug. 23, 1857, married Robert W. Harrah, April 4, 1878; no children. They now (1901) live in Greenbrier county, W. Va.

Bettie A. Montgomery (No. 2, Gen. 7), born May 8, 1860, no information.

John T. Montgomery, born June 29, 1862, married Fannie E. Flubnan, Dec. 28, 1897; one child—Margaret L. Montgomery, born Nov. 4, 1898; lives in Greenbrier county, W. Va.

Louis W. Montgomery, born Feb. 14, 1864, no information.

Nannie C. Montgomery, born Nov. 25, 1866, married J. N. Lowey, Sept. 1894; children four: 1. Oliver E. Lowey, born July 6, 1895, died Sept. 13, 1895. 2. Samuel C. Lowey, born June 28, 1896. 3. The children are all sprightly, interesting, and a great comfort to their parents. John Alex. Montgomery has served as a civil engineer successfully and William G. stood high in his class in college and received some of the honors of the institution. Their mother

is an intelligent, amiable, pious, active member of the Presbyterian church of Lewisburg, W. Va.; stands among the first in sustaining and promoting the benevolent operations of the church and of the community. Mr. Montgomery is an elder in the Presbyterian church, faithful and judicial in council, exemplary and active. He has for many years superintended the Sabbath-school, and frequently represents his church in the courts of presbytery and synod. He has served for many years also as an officer in the bank, to the acceptance of all concerned. He has had delicate health; resides in town, but superintends his valuable farm in the vicinity. Nannie Estaline Lockhart Montgomery, the mother and grandmother of the parties above, was the seventh child of John Montgomery and Elizabeth Nelson. She was married Oct. 4, 1850, to Lyttleton Waddell. He was a grandson of the Rev. James Waddell, whom the Hon. Wm. Wirt, in his sketch-book entitled "British Spy" immortalized under the name of "The Blind Preacher." During the first year of their married life they lived in Stanton, their birth-place, where Mr. Waddell was editor of the "Stanton Spectator."

In 1861 he volunteered as a private soldier in the "Stanton Artillery," then commanded by Captain Imboden. He remained with

this battery until 1862. He afterward served in the signal corps of the army until the close of the war.

In 1874 he moved his family to Charlottesville, Va., where he remained until his death in 1886. For many years he was editor of the Chronicle of Charlottesville.

He was for many years a ruling elder in the Presbyterian church. Failing health led him to give up journalist work and engage in the boot and shoe business.

His widow is living at Charlottesville, Va., surrounded by her four remaining children and nine grandchildren. She was born in 1829. She was for many years very active in Christian work, Sunday-schools and ladies' benevolent societies. For fifteen years she has been distressingly afflicted with rheumatism, and for ten years not able to walk. This seems to be an inheritance in the Montgomery family. Still, amid all this suffering she maintains the sparkle in her bright, dark eyes, and her remarkably fair complexion still shows that she has been very handsome; and she still retains rare intelligence and industry, preferring to labor for the little ones of her grandchildren.

Her husband, her son Charles E., her brother James Montgomery, and a niece named Annie P. Montgomery, all died within two days of each other.

Frank S., her seventh child, a bright and loveable boy, received an injury to one of his eyes from a ball thrown by a playmate, and the sight gradually failing, he became depressed and restless, giving up his position in the "People's National Bank" of Charlottesville and accepting another with a firm in New York, February, 1889. One month after reaching New York he left his boarding-house, telling his landlady he would not be back to tea; that he would take tea with a friend. That was the last ever seen or heard of him. It is supposed that he was either drowned or killed.

Elizabeth St. Clair Waddell married, Sept. 3, 1884. Rev. W. H. McGee, of Mississippi, of the Episcopal faith, and her family is the only non-Presbyterian. Her husband is at present a "missionary to Cuba" and is doing a good work there.

Lucy Douglass Waddell married James B. Wood, on Sept. 3, 1884, of Charlottesville, Va., an energetic young business man; deacon and treasurer of the Presbyterian church. His wife says he is always busy but never too busy to make his home a happy one with his cheerful disposition.

James Nelson Waddell married Margaret Daniel of Memphis, Tenn., Aug. 25, 1897. He succeeded his father in business and carries it on successfully. He is a worthy Christian man, taking an active part in the Sunday-school work of the Presbyterian church.

William Wirt Waddell married Martha Payne of Charlottesville,

Va. He is teller in the "People's National Bank" of that place. He is the third son of the family who has filled satisfactory positions in that bank, Charles E. and Frank S. having been employed before him.

4, Francis E. Irvine (No. 4, Gen. 6), married Neoria Coolter; children two: 1, William Montgomery Irene. 2, Clement M. Irvine.

5, James Estil Irvine (No. 5, Gen. 6), married Hannah M. King, of Waynesboro, Va.; children eight: 1, Wm. K. Irvine. 2,

Eugene C. Irvine. 3, John Montgomery Irvine, unmarried; deputy surveyor, Augusta county, Va. 4, George F. 5, Wayle A. Irvine. 6, James E. Irvine, Jr. 7, Hugart Irvine. 8, Agnes M. Irvine.

1, William K. Irvine (No. 1, Gen. 7), married Anna Brown; children five: 1, Stewart Irvine. 2, Anna K. Irvine. 3, 4 and 5,

2, Eugene C. Irvine (No. 2, Gen. 7), married Sophia Hunter; children six: 1, Mary Irvine. 2, Houston. 3, Nealis. 4, Virgie. 5, Leta. 6, Eugene.

3, John Montgomery Irvine (No. 3, Gen. 7), of Augusta county, Va., is deputy surveyor; unmarried.

4, George F. Irvine (No. 4, Gen. 7), married Mamie Winfree; children one—name not known.

6, James E. Irvine, Jr. (No. 6, Gen. 7), married Mary Stewart, of Augusta county, Va. The mother of these five children died in 1880, being 82 years of age.

6, Hugart Montgomery (No. 6, Gen. 5), born 1801, died 1844. He never married; was a physician of much skill, like his brother William; practiced in the "pastures" of Rockbridge county, and died in 1844, aged 43.

7, Estalene Montgomery (No. 7, Gen. 5), born 1807, died 1829. She was an exemplary, amiable young lady; was affianced to a worthy young man, a student of Union Theological Seminary, Va., but before the consummation of their cherished hopes she died of a fever; and he, having contracted the same malady by attending her during her sickness, died also in a short time. His name was James Robinson.

Those of the above children of Rev. John Montgomery who were married—namely John Thomas and Isabella—now (1878) have 50 grandchildren and 15 great-grandchildren, and none of his descendants have ever brought disgrace on the Montgomery name.

Mollie Montgomery (No. 2, Gen. 4), daughter of John Montgomery, Sr., and Esther Houston, married a Mr. Edmonson and had children:

Ann Montgomery (No. 3, Gen. 4), daughter of John Montgomery, Sr. and Esther Houston, married a Mr. Crasky and had children.

James Montgomery (No. 4, Gen. 4), son of John Montgomery, Sr., and Esther Houston, married a Miss Weir and moved south to the Holston settlement, near Abington, in south-west Virginia, as did several other brothers, with some of the Houstons. All were staunch Presbyterians. We lost connection with those who moved south except a few records mentioned in the Houston genealogy. Of the sons and daughters that remained in Augusta county, Va., we have complete records.

James Montgomery, mentioned in the paragraph above, had eight children—namely:—John, James, Hugh, Jane, Peggie, Polly, Samuel, Esther. Of these children we have been informed by Mr. C. W. McCord, of Mississippi, who married into the family (see below), that Hugh (Generation 5), the third child of James, was married twice and raised a large family in Franklin county, Tenn.; and that Jane (Gen. 5), the fourth child of James Montgomery, married William Moore; they also lived in Franklin county.

Polly Montgomery (No. 6, Gen. 5), married James Cowan, a United States officer in the war of 1812; children six: Samuel M., Betsie, Ann, Julia Doak, Martha, John.

Samuel M. Cowan (No. 1, Gen. 6) married Nancy Clemens; one child—James C. Cowan (Gen. 7), living in Tullahoma, Tenn.

Betsie Cowan (No. 2, Gen. 6), married William Montgomery, her own cousin, a son of Hugh (No. 3) above mentioned; children three: 1, James Chester. 2, Mary Ann. 3, Eva.

Mary Ann Montgomery (No. 2, Gen. 7) married Gen. Nathan B. Forest, of Confederate fame, of Tennessee; children one—Captain William Forest.

Eva Montgomery (No. 3, Gen. 7) married Rev. Lewis C. Taylor; no children.

Ann Cowan (No. 3, Gen. 6) married Alfred M. Cowan; no children.

Julia Doak (No. 4 Gen. 6) married John Davis; children six: 1, James C. Davis. 2, Elizabeth Davis. 3, Mary Polk Davis. 4, Nannie Davis. 5, Thomas Davis. 6, Samuel Davis.

Martha M. Cowan (No. 5, Gen. 6), married first John C. Griffith; second, C. W. McCord; one child—Donna McCord, No. 1, Gen. 7.

John Cowan (No. 6, Gen. 6), married Anna Brown; one child—William Cowan, No 1, Gen 7.

Dorcas Montgomery (No. 5, Gen. 4), daughter of John Montgomery, Sr., and Esther Houston,, married a Mr. Lowery and had five sons: 1, John M. 2, David. 3, Robert E. 4, James. 5, William.

John M. Lowery (No. 1, Gen 5), married —; children —.

David Lowery (No. 2, Gen. 5), married —; children —.

Robert Lowery (No. 3, Gen. 5) married Elizabeth Moore, daughter of Wm. Moore and Elizabeth Steel, of Augusta county, Va.; children William Moore (No. 1, Gen. 6), John Moore (No. 2, Gen. 6), and some others.

Jane Montgomery (No. 6, Gen. 4), daughter of John Montgomery and Esther Houston, married Samuel Newel; had a large family: Samuel B. Newel (No. 1, Gen. 5), married —; only know of one son, Samuel A. Newel (No. 1, Gen .6). A daughter of Jane Mont-

gomery and Samuel Newel, Sr., married a Mr. Owen and had three sons.

Robert Montgomery (No. 7, Gen. 8), son of John Montgomery, Sr., and Esther Houston, married a Coleville; children six (Gen. 7): Juliet Montgomery, A. C. Montgomery, John C. Montgomery, Polly Montgomery, Jane Montgomery and Sallie Montgomery.

Esther Montgomery (No. 8, Gen. 4), daughter of John Montgomery, Sr., and Esther Houston, married Rev. Samuel Doak, D. D.; children two: Samuel and John W.

Samuel Doak, D. D., Jr. (No. 1, Gen. 5), married Sarah McEwen, his step-sister; no children.

Rev. John W. Doak (No. 2, Gen. 5), married Miss Alexander, a sister to Dr. A. Alexander, of Princeton Theological Seminary; one son.

Rev. Archibald Alex. Doak (No. 1, Gen. 6), married Miss Cowan, daughter of Sallie Paxton-Cowan, sister of John D. Paxton, D. D., of Kentucky; children seven (Gen. 7): 1, H. M. Doak, clerk of the U. S. court at Nashville, Tenn. 2, James Hall Doak, died in the Confederate army, 1862. 3, Rev. Al. Sidney Doak, lately pastor of Alabama Street church in Salem; now at Woodlawn, Ala. 4, Samuel Tyler Coleridge Doak, lives in Nashville, Tenn. 5, William Edmonson Henry Doak, lives in Nashville, Tenn. 6, Mabel Doak, died young. 7, Sarah Jane Doak, died young. 8, Sallie Doak, married Benjamin Shaw and lives at Clarksville, Tenn.

Dr. Samuel Doak, Sr., married second Margaret McEwen, the widow of Alex. McEwen and sister to Rev. Samuel Houston of Rockbridge county, Va. By her first husband she had four sons and one daughter. By her second marriage she had no children. Her only daughter married Samuel Doak, D. D., Jr., her step-brother, as stated above.

Alexander Montgomery (No. 9, Gen. 4), son of John Montgomery, Sr., and Esther Houston—of him we have no positive knowledge. We hear that he lived in Aione county, Tenn., at Scoverville, and was a justice of the peace for the county in 1796. He was a Ranger in 1794 and 1796.—See Ramsey's Annals of Tennessee.

Isabella Montgomery (No. 10, Gen. 4), daughter of John Montgomery Sr., and Esther Houston, married Mr. Brinkman.

There were two other daughters in the family of John Montgomery, Sr., but we have no knowledge of their descent.
