James Sproule Montgomery (59) and Samuel Montgomery (62) lived many years in New Albany, Ind., and both died there; were both men of great energy and industry, fine ability and commanding presence. They both began life in the humble capacity of deck hands on steamboats plying the Ohio and Mississippi rivers, and arose to be captains of the largest boats on those rivers, amassed large means, and engaged in the banking business in their home city, and James S. Montgomery was honored with the position of president of the old mail line between Cincinnati and Louisville.

They died in their home city full of years and honors, respected by all who knew them.

Following is taken from the Chicago Inter Ocean, issue of Aug-

ust 5, 1902, and it gives quite a life history of Commodore Joseph Edward Montgomery (67), whose death had just occurred:

"Joseph Edward Montgomery, one of the naval commanders of the Confederacy during the civil war, died early yesterday morning at the home of his son, Dr. James Montgomery, 183 Cass street. He had been ill several weeks.

"Funeral services were held at the residence at 4 o'clock in the afternoon by the Rev. Dr. Brewer. Last night the body was taken to New Albany, Ind., for burial in the family lot. The immediate

family and a few intimate friends accompanied it.

"Commodore Montgomery's health had not been good for several years. He was 85 years old, and his failing sight prevented him from leading the active life to which he was accustomed before he came to Chicago, twelve years ago. Gradually he lost interest in life, and when he caught cold the early part of last month his physicians predicted that he would not recover.

"During and preceding the civil war Commodore Montgomery was among the most noted of Mississippi steamboat commanders. It was his exact acquaintance with the river, coupled with his farsightednss and ability to command, that caused Jefferson Davis to place him in command of the fleet on the Mississipi river. He was

an intimate friend of the President of the Confederacy.

"Montgomery's first engagement was at Fort Pillow in 1862, where he quit the fight with credit to his fleet. When he was attacked by the Union fleet at Memphis he was defeated and the entire Confederate fleet destroyed. After the loss of his fleet he superintended the construction of the gunboat Nashville, and when it was completed took it to Mobile. He attended to the mining of the Bay of Mobile. After the fight there in 1865 he attempted to cross overland to Texas and was captured by Union troops and held until the conclusion of the war, when he was pardoned by President Johnson.

"Commodore Montgomery would have been a widely-known man had there been no civil war. His name was known from end to end of the Mississippi river. It was he who taught Samuel L. Clemens how to pilot a river boat. He was a friend of Charles Dickens, having become acquainted with the English author while yet a river captain. At one time he was a Biblical student at Washington, D. C.

"Commodore Montgomery was a native of Kentucky, having been born at Carrollton May 6, 1817. His father was Joseph Montgomery, a soldier of the war of 1812 and of revolutionary descent.

"One of Commodore Montgomery's most daring feats was an attempt to capture General Grant at about the time of the battle of Belmont. He was head of a little band of scouts, and one of these, pretending to be a spy for the Federals, got General Grant to meet him in a lonely spot. Grant was accompanied by only one aid, and Commodore Montgomery thought he surely had him; but all he got was the Northern leader's horse, the general riding away on his staff officer's steed.

"Mr. Montgomery came to Chicago in 1890, and since then Mrs. Clara White, his daughter, has been his constant companion. She is writing a history of his life, two volumes of which are finished.

"There is pending before Congress a claim in favor of Commo-

dore Montgomery amounting to \$1,000.000, for twenty-five boats and cotton belonging to him which were confiscated by the Federal government at the time of the war." -

The only other member of this generation still living is Mrs. Elizabeth N. Dashiell (68). She is the widow of J. T. Dashiell, who died in the year 1900, and who, during the exciting times of the civil war, was a member of the Indiana legislature, and altogether was one of the best men the writer ever knew.

Hugh Montgomery (96) of Warsaw, Ky., a brother of H. P. Montgomery, mentioned in this work, is now closing the last days of his eighty-second year; has for many years been a Justice of the Peace of his county, and has by industry and business sagacity accumulated a large estate; but he is remarkable in this, that he seeks opportunities to befriend the poor and oppressed. His sympathies go out to save for the owners their property when creditors are about to take their homes from them. When a man has meritorious characteristics, and his property has been sold, Hugh Mongomery looks out for the time when right of redemption of the home expires, comes foward, furnishes the redemption money, gives the debtor time, and by his advice and influence enables him to pay off the oppressive debt. On one occasion the last day for redemption had come to a poor debtor, and the last hope of saving the home was gone when Hugh Montgomery came forward and paid the debt and divided the land with the debtor, gave one-half to him upon which to earn a living and took possession of the other half and managed it for a few years and made four crops, enough to pay all the debt, and then restored to the debtor all the land clear of incumbrance. Such men as these are rare but they understand and follow that rule the greatest of all-the Golden Rule. How much better would our race be if all men would copy his example!

George W. Montgomery (103) lived the greater part of his life in Ray County, Missouri, of which he was one of the associate judges of the county court. In the civil war he espoused the cause of the Confederacy and was a member of the regiment of Col. John T. Hughes of Missouri, and fought under General Price in his campaign in Missouri and Arkansas, and was wounded at the battle of Pea Ridge.

"Prominent Bankers of America," page 544: "Henry Partlow Montgomery (105), President of the First National Bank of Georgetown, Ky., was born in Gallatin county, Kentucky, February 8th, 1839. His grandfather, Robert Montgomery, was a revolutionary hero, and was wounded at the battle of Guilford Courthouse in North Carolina. Mr. Montgomery's lineage on both sides is eminently honorable. He was very carefully educated and, in 1860, graduated from Center College, Danville, Ky., with the second honor in a class of thirty-live. He then read law in the office of H. J. Abbett of Warsaw, and was admitted to the bar of Gallatin county. Mr. Montgomery began practice in Shelby county, but after one year removed

to Owenton, where he acquired and maintained a lucretive business until he transferred his office to Georgetown in 1882, where he now resides. While in Owenton he served seven years as county attorney, an office which involves the duty of public prosecutions. This position is considered a recognition of superior abilities, especially when conferred on a young man. He has also held the position of Special Circuit Judge. It may be mentioned here that he was associate counsel for the defense in the celebrated case of the commonwealth of Kentucky against Thomas Buford, indicted for the murder of Judge John M. Elliott of the Court of Appeals. The organization of the First National Bank of Georgetown, in 1883, was partly facilitated by Judge Montgomery, and he has been its president since that date. He is also president of the Water Supply Company, which also furnishes electric light to the city, and he is active in all local matters tending to advance the education, morals and well-being of the citizens."

Note by D. B. M.:

I now have this to say further of Judge H. P. Montgomerv, of Georgetown, Ky., in addition to the biography copied from "Prominent Bankers of America:" By invitation I visited him Nov. 28, 1900, and found him to be a prominent and wealthy man, probably worth one hundred thousand dollars. He owns thirteen hundred acres of land, nearly all in the very heart of the Blue Grass country. besides owning moneyed interests in nearly all the enterprises of his city. He is a lawyer of high standing and enjoys a lucretive practice. He is strictly honest in his dealings with plaintiff and defendant; this I observed while in his busy office for one day. He is systematic in all his work; he opens business promptly at 8 o'clock A. M., and closes just as promptly at 4 in the afternoon; and all this time he is a busy man, and thus it has been for forty years. He lives in the west part of Georgetown; his house, of stone and brick, is one of the finest in the city. The dwelling is near the center of a whole block and is elevated perhaps ten feet above the streets, the sides next the streets being supported by stone walls. Mr. Montgomery is a cripple, not having walked without crutches since five years old, and he weighs over three hundred pounds. He is happily surrounded with an interesting family. He has good social qualities, and, like other best of men, enjoys a little fun now and then. He is much interested in the history of the Scotch-Irish branch of the Montgomery family in America, and has rendered much valuable assistance in this direction.

Judge H. P. Montgomery has this to say about the part acted by the Montgomery family in the world: "In every war in Europe and America, since 900, the family has furnished its privates, captains, colonels and generals, and the muses have furnished poesy, and the halls of leigslation have been benefited by their wisdom. The bar has been honored, and the pulpit adorned, and medical science advanced. You will say that I am vainglorious about my family, and I admit that I am proud of its record, whether on the tented field or the realms of literature, the pulpit or the forum, or in the humble sphere of the yoeman; and the more I learn of its history, the prouder I am of it."
