New Directors Elected, Annual Fees Ratified

During the recent elections held during July-September 2005, CWSW Council Members elected James L. Wallace, from Bowie, Maryland, to the Board and re-elected incumbents Charles M. Wallace, of Macon, Georgia, Jean Robinson Wallace, from Little Rock, Arkansas, and Marcus J. Wallace, of Corinth, Texas. All these Board Members will serve three-year terms beginning on 01 January 2006.

On the ballot this year was the Approval of Revised By-Laws for the Society. Mostly this By-Laws Amendment, which was passed by a clear majority vote, was a simple formatting of the entire text and making them more modern and readable. The 2004 decision to go to Annual Memberships and to increase the cost of Life and Council Memberships was also incorporated in the re-write.

As was announced in some detail on Page 2 in the Summer 2005 Gleidhidh (Vol 39. No.2) it is currently anticipated that the new Annual Membership System will become effective on 01 January 2006. This delay in implementation is to give current Society Life Members a grace period to allow them to upgrade their Life Memberships to Council Memberships before the price increase and to further allow non-members to apply for memberships before the new system goes into effect. This is a splendid opportunity to purchase Life or Council memberships for family members as

gifts for the up-coming holidays. Con-venors who have Fall Games and Festivals will be prepared to take membership applications. Application forms can also be downloaded from the Society Website, and as always, interested persons can upgrade or join by contacting the Society Membership Chairs.

As previously emphasized, Members who are officially on the CWSW roles as of 1 January 2006 will be forever exempt from annual dues donations, as they are "grand fathered" under the approved By-Laws.

Please remember though, that after 01 January 2006, all Annual and Life Members who want to upgrade will fall under the new rules and will have to pay \$175.00 instead of the current \$50.00. NOW IS THE TIME TO UPGRADE AND TO JOIN!

When the new system goes into effect in 2006, look for a new Clan Wallace Society Worldwide Membership Tri-Fold in color and a newly designed Application Form to compliment the colorful Membership Certificates, which we started issuing last year.

Southern Ontario Festival Circuit

Convenor Dorothy Knight, Woodslee, ON, sends in her seasonal report: "The Highland festivals and games season has come to a close here in Ontario. It has been a very busy year for my husband, Norm, and I. This year, we had 2 first-time experiences. First, we attended the community of Calendar in northern Ontario, which has been holding a Scottish festival for a number of years. We were scouting it out for the future. There was only one clan convening, but dancing, heavy events and pipe bands carried the day. Perhaps, Clan Wallace's participation in 2006 will make it two clans. Our second adventure was at Kincardine, on beautiful "Loch Huron." This time we hosted the Wallace tent and received a warm welcome and many convenors from other clans shared that they were "very happy to have Clan Wallace join us." Clan Gordon was the honored clan this year, and there were eight to ten clans represented. We had several serious inquiries about CWS membership. Kincardine is a fun town....every evening at sunset a 'phantom piper' plays near the lighthouse. The legend is that a Scottish family was lost on the lake, and through the fog, the husband heard a piper on shore. The family followed the call of the pipes to safety. As well, the massed pipes and drums parade down the main thoroughfare on the Saturday evening of the festival. The grand finale is a super ceilidh at a local park. This was the 60th anniversary of the Fergus Festival and Games. Mr. John Campbell, who retired as director of the avenue of the clans after 35 years service, hoped to have 60 clans in 2005. He came close; there were 54. Here, the response at the Wallace tent was exceptional with over 25 signing the guest book, and we handed out just as many membership forms. If only they would all send them back with their fees. Indeed, interest was high at all the games this summer. Chatham was good. Sarnia a little slower due to bad weather. Of special note, the Windsor (ON) Police Pipe Band (Gr.2) placed 3rd in the Glasgow International Competition. (Windsor is Detroit's twin city.) Yay, Windsor! If convening weren't enough, on 25 September 2005 I was asked to participate in an unveiling of a Wallace mural in Wallaceburg (see Page 6). Wallaceburg is the only town in Ontario named for William Wallace." Yes, Dorothy, it has been a very busy season for you, indeed.



The Annual Directors Meeting in Salado, Texas was a huge success. The weather was great for the first time in four years.

Mural Commemorates W-700

Convenor Dorothy Wallace Knight of South Woodlee, Ontario, represented the CWSW at the unveiling of a 16' x 20' mural on Wallace Street in Wallaceburg, ON, on 25 September 2005. Wallaceburg is 30 miles northeast of Detroit, across Lake St. Clair. The town, formerly Baldoon, was renamed in the 1830's by Scottish immigrants in recognition of William Wallace's struggle against "English oppression."

The "Wallace Mural" was commissioned by the town's bicentennial committee to commemorate the 700th anniversary of Sir William Wallace's death. In 2004, the town was festooned in Modern Red Wallace Tartan. Dorothy (R) was asked by Chair Sally Mahoney (L) to speak on Wallace's significance and to bring greetings from the Clan Wallace. Andrew Wallace: Clan Wallace's Future Chief

Following in the footsteps of such forebears as Sir William Wallace can't be easy, but Andrew, next to lead the Clan and Family of Wallace, continues to define the role of "today's chief." Many members of the Clan Wallace had an opportunity to meet with Andrew Wallace, eldest son of Ian Francis Wallace of that ilk, current and 35th Chief of Clan Wallace.

The romanticized image of Scottish chieftain calls to mind a solitary man in a tartan kilt striding across heather-coated hills bagpipes wailing in the distance. Such images are increasingly difficult to maintain in the modern information age.

To a degree, this description fits Andrew Wallace, next in line to inherit the title of Chief of Clan Wallace. He walks the countryside, many miles at a time, and feels the same "Scottish prejudice" that boiled in Roberts Burns' blood. But the tall, often witty Edinburghian turns serious as he envisions the much more modern role (that of ambassador rather than leader) he will assume when he succeeds his father, Ian Francis Wallace, the Clans' 35th Chief.

As the role of the Clan leader continues to evolve, a 21st century Chief also needs to remember to approach the role with humility. Andrew believes that a modern Chief should avoid seeking power and profit.

What it's all about now is not necessarily anything to do with the family per se, or

the clan system," Andrew explains. "It's just the fact that there are a lot of Scots all over the world who seriously value their Scottish roots. Given that, and given the fact that they identify with heads of their family, the modern role is to revitalize the idea of the extended family, which is what it was all about to start with, and have it as a form of kinship."

Upon his accession, Andrew Wallace will become the 36th Chief of Clan Wallace.
